Monday, January 14, 2019 Following the Budget Hearing

**19-001** Motion by Mrs. Whitaker, seconded by Ms. King, that Mrs. Keller be elected President of the Board of Education for the calendar year 2019. Mrs. Whitaker closed nominations.

Roll Call: Mrs. Whitaker-yes, Ms. King-yes, Mrs. Armstrong-yes, Mrs. Keller-yes, Mr. Popo-no. Motion carried.

Treasurer, Christy Moore, administered the oath of office to the President. The President assumed the Chair.

**19-002** Motion by Mrs. Whitaker, seconded by Mrs. Keller, that Carol King be elected Vice President of the Board of Education for the calendar year 2019. Mrs. Whitaker closed nominations.

Treasurer, Christy Moore, administered the oath of office to the Vice President.

**19-003** Motion by Mrs. Armstrong, seconded by Mrs. Whitaker that the following resolution be adopted:

## RESOLUTION REQUESTING ADVANCE FROM COUNTY AUDITOR

BE IT RESOLVED by the Board of Education of the Walnut Township Local School District, County of Fairfield, State of Ohio:

<u>Section 1:</u> That the Auditor of Fairfield County be and she is hereby requested to issue an order to the Treasurer of Fairfield County to pay to the Treasurer of this Board of Education such funds as may be available for distribution by said County Treasurer.

<u>Section 2:</u> That the Treasurer be and she is hereby authorized to sign the necessary documents to secure such advances and also the secondary documents to secure the semi-annual settlement with the County Treasurer.

<u>Section 3:</u> That the Treasurer of the Board of Education be and she is hereby authorized and directed to certify a copy of this resolution to the County Auditor and make such other certifications and reports to the County Auditor as may be necessary to make this resolution effective.

**19-006** Motion by Mrs. Armstrong, seconded by Mrs. Whitaker, to adopt the Tax Budget for Fiscal Year 2020, as presented, and to direct the Treasurer to submit it to the County Auditor no later than January 20, 2019.

**19-008** Motion by Mrs. Armstrong, seconded by Mrs. Whitaker, to authorize the Superintendent to employ such temporary personnel as needed for emergency situations. Such employment to be presented for approval by the Board of Education at the next regular meeting.

**19-009** Motion by Mrs. Whitaker, seconded by Mrs. Armstrong, that the following reorganization resolution be adopted:

## **REORGANIZATION RESOLUTION**

(1) BE IT RESOLVED THAT the existing printed policies, rules, and regulations of the Walnut Township Local Board of Education be adopted until changed by official action of the Board; and further, that existing agreements between the Board and Walnut Township Education Association (WTEA) be continued until changed by official Board action.

(2) BE IT RESOLVED THAT the Walnut Township Local Board of Education waives the reading of the minutes of meetings provided such record has been distributed to the members at least two days prior to the next meeting and that copies of such record are made available to the public and to the news media at the time of the meeting.

(3) BE IT RESOLVED THAT the Board of Education, as authorized by Section 3313.18 Revised Code of Ohio, hereby dispenses with the adoption during the year of resolutions:

- a) authorizing the purchase or sale of property except real estate;
- b) approving warrants for payment of any claim from school funds, and;
- c) authorizing the payment of debts or claims and the salaries of employees as fixed by the Board.

(4) BE IT RESOLVED THAT the following is hereby adopted to a part of the rules and policies of the Board for the School District; pursuant to the authority contained in Section 3313.20 Ohio Revised Code and other applicable law:

- a) Members of the Board of Education or employees of the Board may receive regular compensation and/or reimbursement for expenses of attending a professional meeting or attending to official business of this School District, provided any such meeting or business is outside the territorial limits of the School District. Payment shall be made upon delivery of receipts evidencing such expenditures, plus expenditures for meals.
- b) Attendance at and reimbursement for employee professional meetings is subject to prior approval of the Superintendent.
