Walnut Township Local Schools Class of 2020
Scholarship Application Details and Requirements

Students that are graduates of the class of 2020 from Walnut Township Local Schools are eligible to apply for scholarships from the remaining funds from the class account which, by a class vote, have been donated to the Sweet Corn Festival, LLC to distribute to graduates on a first come, first served basis. The following eligibility requirements must be met in order to apply for and receive funds:

1. Must be a graduate of the Class of 2020 from Walnut Township Local Schools as verified by the Walnut Township Local School District. **MAIL APPLICATIONS TO: SWEET CORN FESTIVAL LLC, 11850 LANCASTER STREET, MILLERSPORT OH 43046 OR DROP OFF AT WALNUT TOWNSHIP LOCAL SCHOOLS DISTRICT OFFICE.** WTLS D will only verify graduates and pass applications along to the Sweet Corn Festival.
2. Class of 2020 graduates from Walnut Township Local Schools may apply for post-secondary (2-year, 4-year, trade school, professional school and training programs) related educational expenses, including the following:
 - a. Tuition
 - b. Books and/or materials required for post-secondary study
 - c. Evidence of a paid receipt is required as a part of the submission requirements
3. Class of 2020 graduates from Walnut Township Local Schools may apply for work-related expenses related to expenses for successful employment, including the following:
 - a. Training
 - b. Equipment and/or materials required to perform a specified job
 - c. Uniforms including steel toe boots or other specialized apparel
 - d. Evidence of a paid receipt and evidence (i.e. letter from employer, copy of industry standards) that outline required equipment and/or training needed for employment.
 - i. Example: A student could submit the cost of purchasing a welder for use as a welder and could submit a letter from employer requiring the purchase of a welder OR provide industry standards outlining a welder is needed for the work.
4. The following items are not eligible expenses:
 - a. Mileage and travel (airfare, hotels, rental cars)
 - b. Meals and Alcoholic beverages
 - c. Personal care items
 - d. Equipment and/or technology used for personal use (i.e. cell phone, computer)
Note: Exception to this is equipment and/or technology specifically required for employment.

Sweet Corn Festival, LLC and Walnut Township Local Schools make no guarantees of a certain level of funds for any individual student for any reason. The total funds donated for the scholarship fund total \$19,756.30. Once all funds have been awarded, the application period is closed and neither the SCF nor Walnut Township Local Schools will provide any additional funding of applications.

Applications will be processed in order of receipt until all funds are paid out. Early application is essential. If multiple applications are received at the same time, every attempt will be made to pay out as much as possible for each application. The Sweet Corn Festival, LLC and Walnut Township Local Schools makes no promise of any level of scholarship to any graduate of the Class of 2020.

Incomplete applications will be returned to the applicant to be completed and not processed until a complete application is submitted.
